### **NOTICE FOR WALK-IN-TEST**

The Jammu & Kashmir Biodiversity Council is monitoring the formulation and updation of Peoples Biodiversity Register (PBRs) being prepared by the BMCs in Jammu as well as Kashmir province in UT of J&K. In order to update the PBRs in the field at BMCs level and assist in other assignments of the Council, the Member Secretary J&K Biodiversity Council / Director J&K Forest Research Institute invites applications from interesting candidates of Jammu & Kashmir for a Walk-in-test which would be followed by an interview to engage suitable candidates as Junior Research Fellows (JRFs) purely on temporary basis, for a period of six (06) months under the funding available with the J&K Biodiversity Council which may be extended depending on the availability of funds.
