Training program on Biodiversity Conservation organized for Master Trainers by J&K Biodiversity Council

J&K Biodiversity Council in collaboration with J&K Forest Department Organised a "One Day Training program on Biodiversity Conservation" in Forest Complex Sheikhbagh Srinagar today. The master trainers of Department of Rural Development Department, Urban Local Bodies and other officials participated for training on role and functions of Biodiversity Management Committees, and other important aspects of Biodiversity Act/ Rules. Around 50 participants belonging to Department of Rural Development, Agriculture, Fisheries, WUCMA, Urban Local Bodies, Wildlife and Department of Forest participated in the training programme.

During the programme, PCCF (HoFF) J&K/Chairman, J&K Biodiversity Council Dr. Mohit Gera gave a detailed account of activities of council to ensure Biodiversity Conservation in Jammu & Kashmir and its sustainable utilization. He also highlighted the role of BMCs in Biodiversity Conservation and need to make them aware of their role and responsibilities. He impressed the participants to familiarize themselves with the Biodiversity Conservation issues, functioning of BMC, so that they can play a role of master trainers to train the large number of trainers including from Forest Department for training of BMC members.

Dr. Mohit Gera also spoke about likely impacts of climate change on Biodiversity of Jammu & Kashmir and steps required to protect all life forms and create resilience in the ecosystem. He also impressed upon to create a massive awareness at the gross root level with respect to Biodiversity where BMC need to play a key role. He also informed on various initiatives of Forest Department on active involvement of BMCs in sustainable collection and utilization of Non-Timber Forest Produces (NTFP).

The program started with a welcome address by Sh. Asaf Mehmood Sagar, IFS, APCCF/ Director, J&K Forest Research Institute and Member Secretary, J&K Biodiversity Council in which he discussed about conservation of biodiversity, its sustainable use and fair and equitable sharing of benefits arising out of the use of biological resources.

T. Rabi Kumar APCCF Kashmir spoke in detail in various provisions of Biodiversity Act / Rules and need for a well aware and active BMC. He highlighted the importance of documentation of Biodiversity and traditional knowledge. He strongly advocated the need for creation of awareness with support of master trainers.

Dr. Anzar Khuroo, Member, J&K Biodiversity Council provided useful inputs on process of PBR preparation / updation and the importance of maintaining a People's Biodiversity Registers. He also spoke at length on importance of Biodiversity with special focus on J&K, challenges being faced by the Biodiversity on account of increasing population, consumption and development activities.

Screening of training animated videos was also carried out on Biodiversity Act / Rules, Biodiversity Management Committee and documentation of biodiversity by BMCs.

The PCCF (HoFF) J&K Forest Department/ Chairman, J&K Biodiversity Council, Dr. Mohit Gera in his concluding remarks informed that the Biodiversity Council is taking several initiatives for creation of awareness & training of officials, non-officials members of BMCs etc. through various resources persons for training the BMC members regarding activation of BMCs for building capacity to perform the function as envisaged in Biodiversity Act. The Forest Department also has taken number of steps for sustainable utilization of forest produce and BMCs are being involved along with SHGs. The Council is also getting associated with State Level Livelihood Mission to scale up these initiatives for benefits of Biodiversity Management Committees.
